

# TRIATHLON WA LIFE MEMBERSHIP POLICY



The award of Life Membership is the highest honour Triathlon WA can bestow on an individual and is awarded in recognition of those who have made an outstanding contribution to the existence or effectiveness of the association during their membership. No more than two Life Memberships will be awarded on an annual basis.

## CRITERIA

Each nomination for Life Membership of Triathlon WA should be considered on its individual merits.

Decisions will be made on the basis of:

- Service to Triathlon WA well above what is normally expected;
- Significant leadership within Triathlon WA;
- Outstanding innovation in Triathlon WA activities;
- Strong support for Triathlon WA activities;
- Enhancement of the standing of Triathlon WA in the community;
- Long association with the activities of Triathlon WA;
- Should have a minimum of ten (10) years membership of Triathlon WA, unless exceptional circumstances can be cited.

## PROCESS

1. TWA Board will call for nominations for life membership in the March of the Financial Year preceding the AGM.
2. Nominations must reach the Board no later than the Board Meeting preceding the Triathlete of the Year Awards (generally the May Board meeting)
3. Any current financial member of Triathlon WA may nominate any other current financial member for Life Membership, provided that the nomination is seconded by a third financial member. If the nominee is a Board Member, they will not be involved in any aspect of the selection process.
4. Nominations must be submitted on the appropriate nomination forms. All nomination submissions must address the criteria for selection as outlines above.
5. The nomination must articulate the reasons why Life Membership is considered appropriate. Where possible, specific examples of work or involvement should be cited.
6. Nominations must be treated confidentially by the nominators, the Nominations Panel and the Board.
7. The Board will call for nominations from existing life members to participate on a Nominations panel. The Board will select 2 of the nominees to sit on the Nominations panel. The nominated Life Members must be actively involved in the sport over the past 5 years.
8. The Nominations Panel will consist of 2 active Life Members, the President of TWA & two other Board members
9. The nominations will be discussed by the Nomination Panel prior to being presented to the Board. The Board at the meeting following receipt of the nominations and before the Annual General Meeting will agree on the nominations presented
10. While each nomination is to be treated on its merits, the Board has the information as outlined in the Criteria above to use as guidelines. For the Board to send the nomination forward as a motion at the

Annual General Meeting, the nomination must be supported by at least 75 percent of the membership of the Board. The Board's decision is final.

11. If the Board decide not to support the nomination for Life Membership, then the proposer and seconder of the motion will receive a written notification of the Board's decision, signed by the President of Triathlon WA.
12. If the nomination is successful, then the President of Triathlon WA will present the nomination at the Annual General Meeting for voting as per the Triathlon WA Constitution.
13. The Nominations Panel will also be responsible for recommending nominees for the TWA Service to Sport Award. Refer to the TWA Annual awards and State Series Policy for further details on the Service to Sport Award.

## CONSTITUTION

Below is an expert from the TWA constitution relating to Life Members of Triathlon WA

### 8.4 Life Members

- (1) *The Board may recommend to a General Meeting that any natural person who has rendered distinguished service to Triathlon, Duathlon, Aquathlon in Western Australia through the promotion of the interests and objects of the Association be appointed as a Life Member.*
- (2) *A resolution of a General Meeting to confer life membership (subject to Rule 8.4(3)) on the recommendation of the Board must be a Special Resolution.*
- (3) *A person nominated for Life Membership must accept or reject the Association's resolution to confer life membership in writing. Upon written acceptance, the person's details will be entered upon the Register, and from the time of entry on the Register the person will be a Life Member.*
- (4) *A Life Member may elect to be a Senior Member and will be entitled to all privileges and all obligations of that position.*
