



2022/23 TRIATHLON WA GOLDEN TICKET COMPETITION TERMS AND CONDITIONS

- 1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
- 2. By entering the competition, entrants agree to abide by these Terms and Conditions.
- 3. The Terms and Conditions of this competition are governed by the laws of the State of Western Australia.
- 4. The competition is being run by Triathlon Western Australia Inc, 203 Underwood Avenue Floreat WA ("TWA").
- 5. The Golden Ticket ("the competition") commences at 12:01am Australian Western Standard Time (AWST) on Monday 1 August.
- 6. The closing time for entering the competition is 11:59pm AWST on Wednesday, 31 August 2022.
- 7. Entry to the competition is limited to 2022/23 Triathlon Western Australia financial Standard and Premium Members.
- 8. To enter the competition, the entrant must register and pay their annual Standard or Premium membership fee to TWA/Triathlon Australia.
- 9. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
- 10. Staff employed by TWA and their immediate family members are not eligible to enter the competition.
- 11. There will be one (1) prize. This prize will \$1000 to be used toward race entry to any 2022/23 season TWA sanctioned events of your choice.
- 12. There will be one (1) draw at 10am Australian Western Standard Time on Thursday, 1 September 2022 at the TWA office, 203 Underwood Avenue Floreat WA. The draw will be by random barrel draw from all eligible entries received with the first entry drawn being the prize winner.
- 13. The prize winner will be contacted within seven (7) days of the draw by the email address supplied by the entrant and attached to their GoMembership account and membership.
- 14. If the prize winner does not respond to claim the prize within twenty-one (21) days of the draw, or if they choose to forfeit their prize, a re-draw will be conducted within thirty (30) days of the original draw date, in the same location, and with the same method. Redraws will continue in the same manner until the prize has been claimed by a prize winner.
