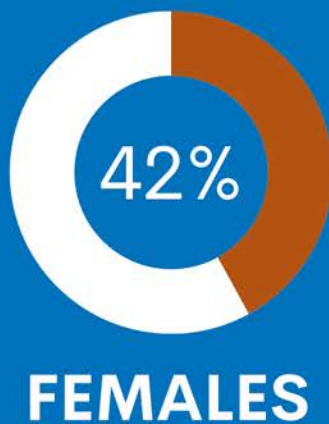
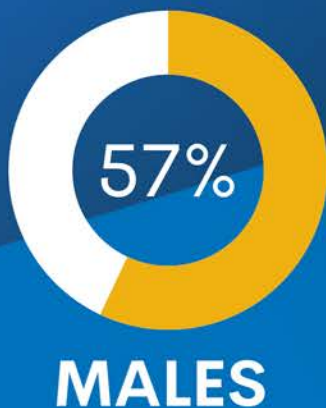

PRESIDENT'S REPORT

Hello to our remarkable Triathlon WA community,

The winds of change have certainly blown through this past year, and what a ride it's been. Our beloved sport has had its share of ups and downs which have brought us new horizons to explore. As an organisation, I'm genuinely proud to share that TWA has risen to meet these challenges, positioning ourselves for growth and enhanced services for our members throughout the state. With my fourth year on the TWA Board and my first as President, it's my honour to present the 2022/23 Annual President's Report.

Our membership numbers have grown, reflecting the continued attraction of our sport and the benefits of membership. Despite this we still have thousands of race starters choosing one day licences over annual membership, a trend we're looking to address through our membership value proposition.

This year's SunSmart Busselton Festival of Triathlon was a shining moment. A three-day celebration of sport filled with thrilling triathlon action and inspiring moments. We were blessed with perfect weather across the weekend. It was sunny and calm for our SunSmart Busselton 100 long course State Championship race on Saturday, with glassy water on the Sunday for our Kids and Foreshore Triathlon athletes. We dialled up the excitement with the Oceania Cup Busselton and Oceania Para Cup Busselton, showcasing elite continental cup racing for our WA triathlon community. There were some outstanding results from our local elite and junior athletes, including a third-place win from local Kurt Wesley. The SunSmart Busselton 100 race itself was a spectacle, showcasing the talent and professionalism of our WA triathletes and event delivery partners. The event was a roaring success, with participation increasing 11% compared to 2022. Keep the cheers coming for the SunSmart Busselton Festival of Triathlon (and by the same token, all our locally run races) – it's an investment in our shared love and passion for the sport.

Our financial health at Triathlon Western Australia is robust, thanks to thoughtful financial management and strong partnerships. Our reserves meet Sport Australia's recommendations, giving us some wiggle room to introduce exciting programs that enhance the sport. We're not immune to inflationary pressures and have seen significant increases in event costs this year. Despite this, we still have some very exciting opportunities in the pipeline and remain committed to increasing investment to enhance member benefits whilst maintaining our strong financial position.

Triathlon Australia rolled out their centralised operational model this year. Without clear benefits to TWA members, your board elected (along with TNSW and TACT) for TWA to remain independent. We continue to work closely with TA and other states, and remain committed to aligning nationally on key operational processes to ensure the best outcomes for our members and our sport.

A round of applause for our stellar TWA Board Members: Henrietta Farell (Vice President), Lauren McGregor (Treasurer), Ashlee Morgan, Emma Ridley, John McCann, Kate McRobb, Bruce McCully, and Morgan Marsh. These folks navigated some hefty challenges and brought their A-game this year. EXECUTIVE DIRECTOR'S REPORT

The 2022/23 season was very much a steppingstone season for Triathlon WA. We experienced membership growth of 7% which represents a very positive outcome and proves that the sport is recovering well post-pandemic. TWA also experienced growth in event participation numbers across the calendar which is a testament to our team, our clubs, our members, and the WA triathlon community.

I personally was very humbled to sit on the Executive Director seat while Ashleigh Apps was on Maternity Leave, and subsequently to see Olivia Birkett take up the role in 2023/24.

The SunSmart Busselton Festival of Triathlon weekend was again a great event that closed out the 2022/23 season. Triathlon WA was fortunate to host two Triathlon Australia and World Triathlon events as part of the Festival – the Oceania Cup Busselton and Oceania Para Cup Busselton. These races not only provided our local elites and juniors with the chance to test their skills on the international stage, but also attracted elite athletes from interstate, New Zealand and Asia to our Festival.

With a full calendar of events in 2022/23, it was great to close out the season with a fun and enjoyable Annual Awards evening. The Awards were held at the DoubleTree by Hilton Perth Waterfront and celebrated the success of our Triathletes of the Year and special award winners. It was fantastic to be there alongside so many of our amazing WA triathlon community members, and we look forward to growing the event in years to come.

Completing the final term of the past Triathlon Strategic plan, Triathlon WA was firmly on track to continue focusing on efficiency, communication and achieving our strategic goals. Building club resources, reducing administration processes, and ensuring clubs are supported with critical services being the core focus.

These goals have been and will continue to be our focus as we move into the coming season with the recruitment of the Triathlon WA Membership and Marketing Manager, Lauren Huddy, who started in April 2023.

There were a few more staffing updates during the 22/23 season. TWA also saw a change in the Pathway Program Lead role with experienced coach Janine Kaye joining the team to lead this development role.

Mike Gee moved into the individual role of Coaching Manager, working with local coaches to deliver Foundation and Development Coaching Courses throughout the season. Cathy Hoare continued in the Technical and Sanctioning Officer position, an experienced contributor to the Triathlon community. The Commercial Operations Manager, Rebecca Bury lead the events development team with support from Volunteer Manager Carlya Bell, and Event and Marketing Coordinator, Tarquin Bateman. These women were a formidable team spearheading the entire organisation's event space. Triathlon WA would also like to acknowledge the work that Emily Ekert (Membership and Marketing Manager) contributed during her time in the office before departing to move interstate in December 2022.

As always, our sport is supported by several partners who invest in the growth and development of Triathlon WA along with all our corporate partners who support our organisation and events.

We thank our community of clubs, coaches, officials, committees, staff, and volunteers for their excellent work. Thank you to the volunteers on the Triathlon WA Board, led by President Brenden Koh, who provide their time, expertise, and support to drive the strategy and long-term direction for the sport. We also thank our committees and working groups who support the Triathlon WA Board throughout the year. We are again looking forward with optimism and we wish you all the best for a successful and prosperous 2023/24 season.

MEMBERSHIP & CLUBS REPORT

The 2022/23 season saw WA Memberships grow by 7% compared to 2021/22. Now in its second year, Triathlon Australia's membership platform GoMembership had auto-renew in place which negated many of the membership renewal issues experienced in previous years and allowed TWA to retain a greater proportion of existing members.

Triathlon Western Australia members ranged in age from seven (7) to eighty (80) years, with 64% of members sitting within the 30-55 year age bracket. There were 1% of members for whom the membership platform did not specify gender.

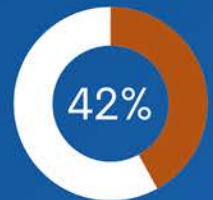
21 affiliated clubs were welcomed back, with reach across the Perth Metropolitan area as well as regional centres including Albany, Bunbury, Busselton, Esperance, Kalgoorlie and Mandurah. Triathlon WA also has several local athletes affiliated to the national club, ADF Triathlon Club. Positively, fifteen (15) affiliated WA clubs experienced a growth in membership in 2022/2023 with the average increase being 18.75%. The two largest clubs, North Coast Triathlon Club and Fremantle Triathlon Club, accounted for 27% of total WA memberships. The top 5 largest clubs (North Coast, Fremantle, Perth, Stadium and Bunbury) accounted for more than 49% of the total WA memberships. WA clubs ranged in size this season from 7 (City Tri Club) to over 328 members (North Coast).

OTHER CLUB NEWS

President catch-ups were held across 2022/23 to bring together local club representatives and provide networking opportunities. During these catch-ups, club presidents were able to discuss common challenges and seek support from other clubs within the Triathlon WA community. Triathlon WA also held a Club Conference in October which featured workshops from leaders in member growth and retention, as well as marketing strategies to further develop local club communities.



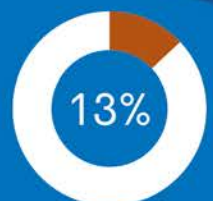

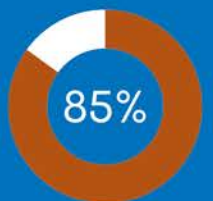
FEMALES

SUNSMART CLUB GRANT FUNDING

With continued supported from SunSmart and Healthway, five (5) clubs were awarded a funding grant of \$1,200 to enact initiatives that increased awareness of the SunSmart message. PARTICIPATION & ENGAGEMENT REPORT

Triathlon WA conducted 38 visits to 13 different schools throughout the 2022/23 season to deliver the Junior TRYStars program. Fourteen (14) of these programs were funded through Sporting Schools. A total of 1,681 students engaged in the schools' programs, creating 4,193 individual exposures to the sport.



SUNSMART KIDS TRIATHLON SERIES

The SunSmart Kids Triathlon (SSKT) Series again had excellent club take-up, with 11 branded kids events across the 2022/23 season. The series is funded by Triathlon WA and supported by Healthway with the aim of creating fun, safe and exciting races for kids aged 7-15 years. More than 600 kids participated in the series overall, which is in line with numbers from last season. Three (3) of the eleven (11) SunSmart Kids Triathlon Series events were held in regional towns: Kalgoorlie, Corrigin, and Busselton. Promoting participation over performance, every child enrolled in a SSKT event received a swim cap and kids finisher medal.

TRYSTARS PROGRAM

The established TRYStars club program returned for 2022/2023 with three (3) clubs running the participation-focused program. North Coast, Fremantle and Busselton Triathlon Clubs conducted 6-8 week programs aimed at juniors 5-15 years old, and provided them the opportunity to try the sport in a safe environment. All TRYStars programs led into a SunSmart Kids Triathlon event to ensure juniors had the chance to test their skills in a race. The aim of this program was to encourage the children to lead an active and healthy lifestyle, emphasizing SunSmart messaging and a have a go attitude.

COME AND TRI WEEK

Triathlon WA once again facilitated the Come & Tri Week initiative for the third year in a row. The aim of Come & Tri Week was to attract new participants to the sport of triathlon across the State.





PARTICIPATION & ENGAGEMENT REPORT CONTINUED

Clubs were encouraged to participate in the initiative by opening their regular training sessions or hosting a specific session for beginners, so they had the opportunity to experience the sport in a safe, welcoming and fun environment. Triathlon WA supported the clubs by providing marketing collateral, promoting the event and taking registrations. Three (3) clubs hosted 22 beginner-friendly sessions over Come & Tri Week in November 2022, resulting in 20 registrations. The sessions were a mix of swimming, cycling and running skills.

ADULT BEGINNERS PROGRAMS

Now in its third year, Clubs were able to apply for funding to run an 8-week SunSmart Time to Tri program. Six (6) programs were held including Women's and Men's only sessions, engaging over 70 new athletes. Triathlon WA also assisted clubs to host a Beginners Workshop and Nutrition Webinar tied to the program.

Additionally, Triathlon WA partnered with recreation centers and clubs to deliver the indoor beginners program TriActive. This 6-week coached program targeted adults starting or returning to regular physical activity and those looking to try something new. Four (4) TriActive courses were held throughout the 2022/23 season - HBF Stadium, Armadale, Perth and Joondalup. Each led into a beginner-friendly race, and all TriActive programs had positive feedback.

TRIATHLON WA OPEN DAY

In November, TWA delivered our Open Day at the Fremantle Surf Life Saving Club (FSLSC). The aim of the event was to create a family-friendly, fun, welcoming environment for members and to attract new participants. There were a number of activities on offer throughout the afternoon including a mini kids aquathlon, workshops (Tri Tips by Julie Pham from Star Physio, Transition Workshop, Tyre Changing Workshop, Nutrition Tips by Gaby Villa from IntenseEATfit), an expo (22 stall holders including clubs and partners), a sausage sizzle, a dunk tank and a face painter. FSLSC was chosen as the venue due to the high foot traffic in the area at this time of year.

60 kids aged 7-15 registered for the Fremantle Ports Kids Splash 'N' Dash and 190 people registered for general entry (free) to the event. There were approximately 30-50 people at each of the workshops.

DEVELOPMENT PATHWAY PROGRAM REPORT

The aim of the TWA Pathway Program (TWAPP) is to provide the Development Triathletes of WA with the foundation to maximise their enjoyment and potential in the sport over time, and to prepare talented athletes for the high-performance pathway when they are older. The Pathway program facilitates development and learning opportunities through skill and education sessions, while also supporting the daily training environment of Pathway athletes and coaches. The program recognises that the key to success for Junior athletes is maintaining good health and wellbeing, consistency, enjoyment, and patience, which are key elements for both longevity and performance in sport.

47 Junior athletes registered for the program this year across 2 intakes, with 10 athletes identified to fit the Talent Criteria, 12 in Development, and 25 in Next Generation.

The education, race and skill sessions during the program in 2022-23 included:

- A joint Draft Legal race day with School Sport WA at Guildford Grammar
- Transition testing with Stuart Durham at Trinity College
- Open Water Swim skills session at Scotch college
- Draft Legal race day and Flow seminar at Woodman point
- Group riding skills with Stuart Durham at St Mary's
- Data collection time trials at HBF stadium and WA Athletics Centre
- DL race day and transition skills development at Champion Lakes
- 2 x Cycling skills sessions with elite cyclist Sabine Bird at Splendid Park Yanchep
- OWS skills session with Mel Tantrum at Coogee
- Travelling camp to Port Adelaide National race
- Velodrome session- end of season activity and skill development

Thank you to Mike Gee for facilitating and supporting the program as Pathway Lead for the start of the season.

RACING OPPORTUNITIES & TOP RESULTS

Local draft legal races were well supported by all the Pathway athletes. It was wonderful to see so many pathway athletes placing well in the TWA State series Triathlete of the year series, with the majority of the podium spots being filled by TWAPP athletes in the relevant junior age groups. We had some great learning experiences and results from national and international racing across the season:

- Australian Junior SuperSprint Championships, Canberra, 12-15 January. Seven WA junior athletes took up the challenge of travelling to the ACT to participate in the multi-day and multiformat race event. Joshua Fletcher was our highest placed male, making the A final and finishing 21st overall. Bridie Crew was our highest placed Female, finishing 27th overall.

DEVELOPMENT PATHWAY PROGRAM REPORT CONTINUED

- Junior Oceania Championships and Junior mixed Relay Championships, Taupo- 25-26 February. Rhianna Hepburn and James Kjellgren Lewis made the trip across the ditch. Rhianna placed 2nd in the individual race, gaining her selection to the Junior World Championship team, and her team were 1st in the Mixed relay.
- School Sport Australia Triathlon Championships, Devonport, 13-16 March. The School Sport WA team was comprised of a majority of TWAPP athletes, with the standout result from Ava Henville taking 1st place in the Intermediate females.
- Oceania U23 & Elite Sprint Champs and Australian Mixed relay, Devonport 18-19 March. Madison Toovey had her first crack at U23 racing and placed 16th. Madi then raced with past program athletes Aleisha Wesley, Luke Bate and Kurt Wesley to become Australian Mixed relay champions.
- Australian Junior Sprint championship, Port Adelaide– April 15-16. Eight WA athletes travelled to SA. Rhianna Hepburn placed 1st cementing her place in the Junior world team. Tommaso Puccini was the highest placed male, finishing 10th.
- Oceania Triathlon Cup, Busselton, 28th April. Several of the older TWAPPP athletes took the opportunity to race in the Elite Super Sprint, with Rhianna Hepburn placing 5th in the Female race, and Reece Harris had a great race to finish 13th in the Mens.
- European Junior Cup- Holten, 2nd July. Rhianna Hepburn raced as part of the Junior World tour and took the win.
- World Triathlon Sprint Championships, Hamburg 15th July. Great racing again from Rhianna Hepburn placing 9th.

TA ROADSHOW

Mick Delamotte and Brendan Sexton visited WA to deliver the TA Roadshow presentation to Pathway athletes, parents and coaches, and other significant stakeholders. The Roadshow presentation covered the aims of the pathway, the TA What it Takes to win modelling, what categorisation looks like and the national strategic alignment around education and skill development. The key takeaway points were patience, enjoyment and engagement.

TWA DEVELOPMENT ATHLETE OF THE YEAR

The past season's challenges from the pandemic continued to linger throughout the 2022/23 season, and Technical Official numbers were still a bit low. The 48 active officials on board this season really rallied together and helped out, with over 160 officiating positions filled by our WA Technical Officials across the season. We had a total of 110 sanctioned events in 2022-23 and sent officials to 35 of them.

New to the calendar this season; the Tiger Snake Classic Triathlon on Garden Island Naval Base provided our officials with a chance to broaden their their horizons with a totally new course - and see some serious boats and submarines!

We had our largest event in December with the GWM IRONMAN WA. 23 Officials stepped up across IRONMAN WA weekend, officiating at both the full IM and 70.3 distance.

The Busselton Festival of Triathlon in April 2023 was elevated by the addition of World Triathlon events Oceania Cup and Oceania Para Cup. This was an excellent opportunity for our local officials to experience international level racing on home soil.

Officials also supported the World Transplant Games triathlon event at Champion Lakes in April. Athletes from 45 countries travelled to compete in inclusive triathlon racing. It was a departure from our regular calendar events but a rewarding and fun day for all.

ROCKINGHAM FORESHORE TRIATHLON

As the sun rose over Rockingham Foreshore on Sunday 5 February 2023, more than 600 athletes were getting ready to compete in the Rockingham Foreshore Triathlon; a State Series event and the State Sprint Championship for the 2022/23 season.

A light spatter of rain and some sea breeze kept things cool for pack pickup and bike racking but the misty morning weather didn't last long, with blue skies and sunshine setting the tone for a fantastic day of racing.

The event comprised of the following distances:

- Draft Legal Sprint Triathlon (750m swim, 20km cycle, 5km run)
- Sprint Triathlon (750m swim, 20km cycle, 5km run)
- Enticer Triathlon (200m swim, 7km cycle, 2km run)
- SunSmart Kids Triathlon (100m swim, 3km cycle, 500m run)

There were a total of 621 registered participants (including each participant on teams), 20 volunteers and an estimated 700 spectators.

SCODY DRAFT LEGAL SPRINT

Rockingham locals and event spectators alike were treated to an exhilarating and fast-paced Sprint race (750m swim, 20km bike, 5km run) featuring the crème de la crème of WA triathlon. People lined the course to cheer the 16-19 Juniors and Open athletes on.

The Open Male field was extremely strong, and featured some of WA's fastest and best male triathletes. In a nail biting sprint to the finish, returning Champion Zeke Tinley (Bunbury) claimed the crown for a second time, crossing the line in a sub-1 hour time of 00:59:14.69 – a second ahead of second place winner Kurt Wesley (North Coast, 00:59:15.34)! The two were neck and neck the entire race, both putting on extremely strong performances throughout the swim, bike and run. Fremantle athlete James Kjellgren-Lewis (01:00:48.60) was less than a minute behind Wesley to claim third, proving he can well and truly hold his own in the Open field. Guy Crawford (Fremantle), Paul McKay (ADF), Reece Harris (Mandurah), Shayne Dimmer (Rockingham) and Rowan Kerr (XTR) rounded out the finishers, with James Martin (Mandurah) and Sam Mileham (Fremantle) unfortunately receiving a DSQ.

In the Open Female field UWA athlete Sian Munks completed the race in a time of just 01:05:40.91 – running through the finish tape to claim the title of 2022/23 State Sprint Champion.



ROCKINGHAM FORESHORE TRIATHLON CONTINUED

Current TOTY Champion Aleisha Wesley (North Coast) was just three seconds behind Munks to claim second (01:05:43.49), followed by Rhianna Hepburn (UWA) in third place with a time of 01:09:36.33. Madison Toovey (North Coast), Herlene Yu (Fremantle) and Regine Goh (UWA) finished in fourth, fifth and sixth place respectively.

Our 16-19 Juniors also put on a phenomenal show, more than keeping up with the older athletes. In the 16-19 Male category Bunbury young-gun Christophe Gardner took home the State Title crossing the line in a blistering 01:02:12.72. Ivan Nagel (EFS) was just 2 seconds behind in second place, and Joshua Fletcher (Exceed) another two seconds behind in third. The 16-19 Female field, although small, was still extremely competitive. North Coast Tri club teammates Erin Driscoll and Bridie Crew finished just 5 seconds apart to claim first and second place.

FREMANTLE PORTS SPRINT

Our Age Group athletes shone in the Fremantle Ports Sprint, taking on the challenge of a 750m swim, 18km cycle, and 5km run along the stunning Rockingham Foreshore.

FREMANTLE PORTS ENTICER

This distance was a State Series race for our 12-13 and 14-15 Juniors, plus a fantastic event for beginners of all ages. Juniors and Age-Groupers took on a 200m swim, 9km cycle, and 2km run.

SUNSMART KIDS TRIATHLON FORESHORE

This triathlon was open to all kids aged 7-15 years and consisted of a 100m swim, 3km cycle and 500m run.

- 5km Fun Run

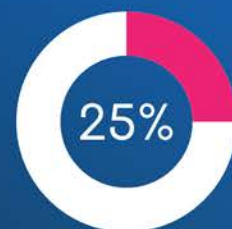
This event focuses on female participation, particularly women who are new or returning to triathlon. As such, the distances are shorter and more attractive for beginners and families.

In partnership with Transplant Australia the event also helped celebrate the efforts of a team of women recovering from organ transplant and training for the World Transplant Games. Transplant group members who were unable to race assisted in recovery and at the finish line as volunteers.

SUNSMART EVERY WOMAN TRIATHLON CONTINUED

Triathlon WA partnered with local charity Share the Dignity Australia to raise more than \$600 toward ending period poverty and providing sanitary items to women in need. Share the Dignity supported the event with an interactive photobooth and stall in the expo area which was very well received.

All athletes who participated in the SunSmart Every Woman Triathlon received a tutu and a finisher medal. There were no winners or losers, and the atmosphere at the finish line was incredibly supportive, with many children joining their mums and grandmothers as they ran down the pink carpet.

Overall, participants rated their experience as being valuable and fun, and 98% intend to participate in triathlon again. As this event builds and grows, it is sure to be an excellent female and junior participation driver.

SUNSMART BUSSELTON FESTIVAL OF TRIATHLON

The 22nd SunSmart Busselton Festival of Triathlon took place at Barnard Park, Busselton between Friday 28 – Sunday 30 April 2023. Nestled between the beautiful Busselton Foreshore, majestic Ludlow Tuart Forest and bustling town, the event site hosted more than 2,000 athletes and hundreds of spectators in the three day celebration of sport.

There were eight events on offer including the SunSmart Busselton 100, Busselton AquaBike, Busselton Foreshore Triathlon Sprint or Enticer, the Busselton Fun Run (500m, 1.6km or 5km) and the SunSmart Kids Triathlon. For the first time in Festival History we hosted the 2023 Oceania Cup Busselton, an elite World Triathlon race in the exciting super sprint eliminator format, and the 2023 Oceania Para Cup which featured some of the Oceania region's best para triathletes.

OCEANIA CUP BUSSELTON

The Festival kicked off on Friday 28 April with the 2023 Oceania Para Cup Busselton. 24 Elite men and 17 Elite women competed, including athletes from Australia, New Zealand, Taiwan, Japan and Singapore. The super sprint format resulted in a phenomenal show, with athletes racing up to 3 rounds of a 250m swim, 6km bike, 1.6km run, with the highest placing athletes going through to the next round.

The top three males ran off the bike in a tight group, each pushing one another to new heights. Luke Willian (AUS) took gold for the men after a huge push on the last corner, with Lachlan Jones (AUS) and local athlete Kurt Wesley rounding out the podium just seconds apart. The female final saw an exciting last lap of the run. The top three women were neck-and-neck the whole course until Charlotte McShane sprinted across the line in first place, just seconds in front of Jessica Ewart-Mctigue, with Ellie Hoitink crossing the line third to claim bronze.

As the sun set on the first day of the festival, the action continued with the Busselton Fun Run! More than 100 athletes competed in the twilight run, with distances on offer including the 500m Dash, 1.6km Magic Mile or the 5km Fun Run. There was significant prize money up for grabs in the 5km Open wave, so we saw a very competitive field with some Australian athletes from the Oceania Cup even returning to the foreshore to try their hand! 22-year-old WA runner Luke Burrows crossed the line in a blistering time of 14:57.90, followed by the east coast Schofield brothers in second and third place. Charlotte McShane backed up her Oceania win with first place in the 5km, her second win for the day in a time of 17:03.58. Runners Amy Buckingham and Lauren French rounded out the top 3.

SUNSMART BUSSELTON 100

Day 2 of the SunSmart Busselton Festival of Triathlon delivered the final event in the Triathlon WA State Series; the State Long Course Championships. More than 1100 athletes took on the iconic SunSmart Busselton 100 event consisting of a 2km swim, 80km bike and 18km run.

SUNSMART BUSSELTON FESTIVAL OF TRIATHLON CONTINUED

Racing conditions were close to perfect, with low winds, flat water and the sunshine warming up the course as the day went on. The atmosphere around the course was incredible. Spectators lined the barriers, cheering friends and family on as they progressed through the course. Club Alley was abuzz with energy, providing that much needed boost of dopamine for our athletes on the run leg. The beautiful blue carpet was waiting, with athletes running down through a chute lined by excited spectators, high fiving and hugging friends before crossing the finish line and receiving that coveted finisher medal.

The Men's open category saw an incredibly competitive field with Kurt Wesley (North Coast), Guy Crawford (Fremantle) and QLD athlete Kye Wylde leading the swim and heading into T1 first. Nick Thompson (UWA), Reece Harris (Mandurah), James Lewin (Stadium) and Ryan Bailie (Bunbury) worked together in a tight pack in the swim coming into T1, boosting each others performances for a quick first leg. Whilst Wylde took the overall win for the SunSmart Busselton 100, Matt Burton (Oceanic) was crowned State Long Course Champion in the Open Male field with a time of just 3:20:18.57. Thompson was hot on his heels (3:21:15.85) to claim second in the State Championship rankings, and Mark Radziejewski just 59 seconds behind Thompson taking home fourth overall and a third place State Champs win.

The Women's Open field consisted of a fast swim by Eastern States athlete Angharad Llewellyn, with endurance triathlon veteran Kate Bevilaqua (Fremantle) second out of the water. Rachael Smyth (Fremantle) had a blistering cycle leg and won the prime which put her into first place, followed closely by Khloe Healy on the bike. Smyth held her lead into the run to take out the overall win, crossing the line under the 4 hour mark with a time of 3:59:59. Cassandra Heaslip outdid Healy in the run securing her second place across the line. Healy followed in third place with a time of 4:05:05. We crowned Rachael Smyth State Long Course Champion with Kate Bevilaqua as runner up for the State Series event.

Brett Johnson (non-club) maintained his title of first Male Age Group athlete across the line with an impressive time of 3:35:10.20. Returning to defend the crown after a win in 2022, Fiona Whelan (Busselton) kept her title as fastest female Age Group Athlete, crossing the line with a time of 4:03:29.71.

OCEANIA PARA CUP BUSSELTON

Day 3, Sunday 30 April 2023, began with an impressive sunrise over the iconic Busselton Jetty, and water conditions were pristine and glassy. The Southwest region certainly treated us to perfect weather with low winds, barely any waves, and lots of sunshine. The 2023 Oceania Para Cup kicked off our morning with a mix of veterans and debutants out on the Barnard Park course, as we crowned nine new Australian Oceania Champions.





SUNSMART BUSSELTON FESTIVAL OF TRIATHLON CONTINUED

WA Locals David Bryant (PTS5) and Sally Pilbeam (PTS4) both took home gold on home turf whilst we saw the return of Brant Garvey (PTS2) who crossed the line with silver for his class. Nige Young (PTWC), Thomas Goodman (PTS2), Liam Twomey (PTS4), Sam Harding (PTVI), Sara Tait (PTWC), Grace Brimelow (PTS2), Maggie Sandles (PTVI) who all took home gold in their respective categories.

SUNSMART KIDS TRIATHLON BUSSELTON

Shortly after the completion of the Oceania Para Cup and a visit from two pods of dolphins, 250 enthusiastic little athletes aged between 7-15 years set off to take part in the SunSmart Kids Triathlon.



The young athletes completed shortened versions of the adult triathlon (Short course: 100m swim, 2km cycle, 500m run & long course: 200m swim, 4km cycle, 1km run), with all athletes showing tenacity, bravery and sportsmanship as they made their way through the course.

The finish chute filled with cheers and energy as they all crossed the line, with many young athletes waiting for friends or siblings on the finish line to congratulate each other and share their experiences of the race.



BUSSELTON FORESHORE TRIATHLON

The weather remained absolutely perfect into the late morning and afternoon for our Foreshore athletes, with aquamarine flat water and blue skies. Enticer athletes were first off the beach with more than 120 athletes tackling a 200m Swim, 8km Bike, and 2km Run. Jude Brimelow (brother of Oceania Para athlete Grace Brimelow) and Isabella Neervort (Fremantle) were the first male and female across the line, both from the 12-13 age group.

We saw some inspiring performances across the field with our oldest athlete in the distance, 72-year-old Keith Purse, completing the course in just 00:42:01.65.



Sprint athletes were next, with more than 350 athletes taking on the 750m Swim, 16km Bike, and 4km Run course. Ivan Nagel (EFS, 00:51:33.04) and Will Cramsie (North Coast, 00:52:49.77) battled it out on course to cross the finish line within a minute of one another and be the first two males across the finish line. Junior athlete Ava Henville (Exceed, 00:55:57.16) was the first female across the line, followed by Erin Driscoll (North Coast, 01:00:19.84).

There were plenty of incredible sprint finishes as the crowd cheered athletes down the final 500m and toward the finish line. We also saw some heart-warming moments from our 12 sprint teams with hi-fives and hugs abundant in recovery.

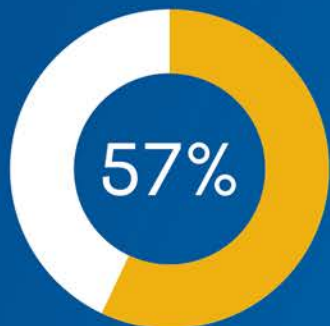

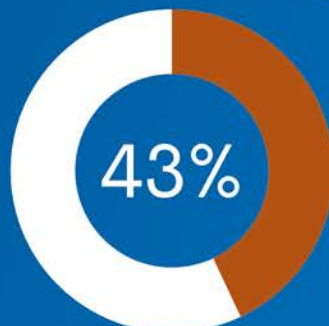



1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Preparation

The financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2015. The Board Members have determined that Triathlon Western Australia Inc. is not a reporting entity.

The financial report covers Triathlon Western Australia Inc. as an individual entity. Triathlon Western Australia Inc. is an association incorporated in Western Australia under the Associations Incorporation Act 2015.

The principal activity of Triathlon Western Australia Inc. is the governance, development and delivery of triathlon, duathlon, aquathlon and health in Western Australia.

The report has been prepared in accordance with the requirements of the Associations Incorporation Act 2015 and the following Australian Accounting Standards:

AASB 101	Presentation of Financial Statements
AASB 107	Statement of Cash Flows
AASB 108	Accounting Policies, Changes in Accounting Estimates and Errors
AASB 1048	Interpretation of Standards
AASB 1054	Australian Additional Disclosures

No other applicable Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accrual basis and is based on historical costs. It does not take into account changing money values, or except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the material accounting policies adopted by Triathlon Western Australia Inc. in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Significant accounting judgments, estimates and assumptions

The carrying amount of certain assets and liabilities is often determined based on estimates and assumptions of future events. The key estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of certain assets and liabilities within the next annual reporting year are:

(i) Impairment of non-financial assets

The Association assesses impairment of all assets at each reporting date by evaluating conditions specific to the Association and to the particular asset that may lead to impairment. These include asset performance, technology and economic and political environments. If an impairment trigger exists, the recoverable amount of the asset is determined.

(ii) Estimation of useful lives of assets

The estimation of the useful lives of assets has been based on historical experience as well as manufacturers' warranties (for plant and equipment) and turnover policies. In addition, the condition of the assets is assessed at least once every year and considered against the remaining useful life. Adjustments to useful lives are made when considered necessary.

(iii) Long service leave

The Association measures long service leave liability based on estimates of future employee retention rates and pay increases.

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, other highly liquid investments with original maturities of three months or less, and bank overdrafts.

For the purposes of the statement of cash flows, cash includes cash and cash equivalents as defined above, net of outstanding bank overdrafts.

Trade and other receivables

A receivable represents the Association's right to an amount of consideration that is unconditional (i.e., only the passage of time is required before payment of the consideration is due). Refer to accounting policies of financial assets, Financial instruments – initial recognition and subsequent measurement.

Financial instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

i) Financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income (OCI), and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Association's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Association has applied the practical expedient, the Association initially measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs.

In order for a financial asset to be classified and measured at amortised cost or fair value through OCI, it needs to give rise to cash flows that are 'solely payments of principal and interest (SPPI)' on the principal amount outstanding. This assessment is referred to as the SPPI test and is performed at an instrument level.

The Association's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both.

Subsequent measurement

For purposes of subsequent measurement, financial assets are classified in four categories:

- Financial assets at amortised cost (debt instruments)
- Financial assets at fair value through OCI with recycling of cumulative gains and losses (debt instruments)
- Financial assets designated at fair value through OCI with no recycling of cumulative gains and losses upon derecognition (equity instruments)
- Financial assets at fair value through profit or loss.

Financial assets at amortised cost (debt instruments)

This category is the most relevant to the Association. The Association measures financial assets at amortised cost if both of the following conditions are met:

- The financial asset is held within a business model with the objective to hold financial assets in order to collect contractual cash flows; and
- The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding

Financial assets at amortised cost are subsequently measured using the effective interest (EIR) method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

The Association's financial assets at amortised cost includes cash and cash equivalents and trade and other receivables.

Financial instruments (continued)

Derecognition

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised when:

- The rights to receive cash flows from the asset have expired; or
- The Association has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a ‘pass-through’ arrangement; and either (a) the Association has transferred substantially all the risks and rewards of the asset, or (b) the Association has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Association has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risks and rewards of ownership. When it has neither transferred nor retained substantially all of the risks and rewards of the asset, nor transferred control of the asset, the Association continues to recognise the transferred asset to the extent of its continuing involvement. In that case, the Association also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Association has retained.

Impairment of financial assets

The Association recognises an allowance for expected credit losses (ECLs) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Association expects to receive, discounted at an approximation of the original effective interest rate.

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12-months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

For trade receivables, the Association applies a simplified approach in calculating ECLs. Therefore, the Association does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Association has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

The Association considers a financial asset in default when contractual payments are 60 days past due. However, in certain cases, the Association may also consider a financial asset to be in default when internal or external information indicates that the Association is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Association. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial instruments (continued)

ii) Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, and payables.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Association's financial liabilities include trade and other payables.

Subsequent measurement

The measurement of financial liabilities depends on their classification, as described below:

Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss.

Financial liabilities are classified as held for trading if they are incurred for the purpose of repurchasing in the near term.

Gains or losses on liabilities held for trading are recognised in the statement of profit or loss.

Financial liabilities designated upon initial recognition at fair value through profit or loss are designated at the initial date of recognition, and only if the criteria in AASB 9: Financial instruments are satisfied. The Association has not designated any financial liability as at fair value through profit or loss.

Derecognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of profit or loss.

Plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and any accumulated impairment losses. Such cost includes the cost of replacing parts that are eligible for capitalisation when the cost of replacing the parts is incurred. All other repairs and maintenance are recognised in the profit or loss as incurred.

The cost of each item of plant and equipment is written off over its expected economic life, adjusted for any salvage value if applicable. Depreciation is provided for at the rates specified in the small business entity simplified depreciation tax rules.

Derecognition

An item of plant and equipment is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal.

Impairment

Plant and equipment is reviewed for impairment if there is any indication that the carrying amount may not be recoverable.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Intangible assets

Intangible assets acquired separately are measured on initial recognition at cost. Following initial recognition, intangible assets are carried at cost less any accumulated amortisation and accumulated impairment losses. Internally generated intangibles are not capitalised and the related expenditure is reflected in profit or loss in the period in which it is incurred.

The useful lives of intangible assets are assessed as either finite or indefinite. Intangible assets with finite lives are amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at the end of each reporting period. Changes in the expected useful life or the expected pattern of consumption of future economic benefits embodied in the asset are considered to modify the amortisation period or method, as appropriate, and are treated as changes in accounting estimates. The amortisation expense on intangible assets with finite lives is recognised in the statement of profit or loss and other comprehensive income in the expense category that is consistent with the function of the intangible assets.

Intangible assets with indefinite useful lives are not amortised, but are tested for impairment annually. The assessment of indefinite life is reviewed annually to determine whether the indefinite life continues to be supportable. If not, the change in useful life from indefinite to finite is made on a prospective basis.

Websites

Websites are initially recognised at cost and are amortised on a straight-line basis over 5 years.

Trade and other payables

Trade payables and other payables are carried at amortised cost and due to their short-term nature are not discounted. They represent liabilities for goods and services provided to the Association prior to the end of the financial year that are unpaid and arise when the Association becomes obliged to make future payments in respect of the purchase of these goods and services. The amounts are unsecured and are usually paid within 30 days of recognition.

Provisions

Provisions are recognised when Triathlon Western Australia Inc. has legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result, and that outflow can be reliably measured.

Provision recognised represent the best estimate of the amounts required to settle the obligation at reporting date.

GST

Revenues, expenses and assets are recognised net of the amount of GST except:

- when the GST incurred on a purchase of goods and services is not recoverable from the taxation authority, in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item as applicable, and
- receivables and payables, which are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or payables in the statement of financial position.

Commitments are disclosed net of the amount of GST recoverable from, or payable to, the taxation authority.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Employee entitlements

- (i) Wages, salaries and annual leave

Liabilities for wages and salaries, including non-monetary benefits and annual leave expected to be settled within 12 months of the reporting date are recognised in respect of employees' services up to the reporting date. They are measured at the amounts expected to be paid when the liabilities are settled and reported as current liabilities in the statement of financial position.

- (ii) Long service leave and other employee entitlements expected to be settled more than 12 months from the reporting date

The liability for long service leave and other employee entitlements expected to be settled more than 12 months from the reporting date is recognised and measured as the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures, and years of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currencies that match, as closely as possible the estimated future cash outflows.

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Revenue recognition relating to the provision of services is determined with reference to the stage of completion of the transaction at reporting date and where outcome of the contract can be estimated reliably. Stage of completion is determined with reference to the services performed to date as a percentage of total anticipated services to be performed. Where the outcome cannot be estimated reliably, revenue is recognised only to the extent that related expenditure is recoverable.

All revenue is stated net of the amount of goods and services tax (GST).

Grants and Subsidies

Grant income for contracts with sufficiently specific performance obligations is recognised over time as the performance obligations are satisfied. Grant income for contracts that do not have sufficiently specific performance obligations is recognised immediately upon receipt.

Income Tax

The financial statements have been prepared on the basis that Triathlon Western Australia Inc. is exempt from income tax.

Comparative information

Comparative information has been restated wherever possible to conform to current year figures.


