# Triathlon WA AGM – 21<sup>st</sup> October 2023

## **Executive Summary**

Triathlon WA is seeking two experienced Board candidates with skills that align with the strategic direction of the organisation and complement the current skills mix of the Board.

Board members contribute to the overall governance activities of the Board, including providing input on the matters of corporate strategy, policy formulation and implementation, Executive Director performance, as well as oversight of the financial performance, risk management and compliance. The Board plays an important role in the continued progression, improvement, and growth of the sport in WA.

The current Board recently completed a skills matrix, and it identified four areas that are of strategic importance for future Board Members to fill in terms of their skills and experience. All Board candidates were asked to identify relevant experience one or more of the following skills:

- Diversity and Inclusion
- Human Resources/People and Culture
- Information Technology
- Legal

In addition to these specific skills, Board Members should have experience within:

- Strategic Planning
- Governance
- Risk Management and
- Financial Management

A call for nominations was circulated Monday 4<sup>th</sup> September, 45 days prior to the AGM as per the Triathlon WA constitution. Four candidates submitted valid nominations, for two positions, therefore a vote by the members at the Annual General Meeting will be required.

The Board would like to thank current President Brenden Koh for all the work he has done for the organisation over the past 4 years and support his decision to nominate for the Board for another term.

The Board greatly appreciates the interest from all candidates, demonstrating their support of triathlon in Western Australia. Whether elected or appointed to the Board, other roles exist on various Board committees. There are many ways for those interested in the governance of Triathlon WA, to contribute to the sport.

### **Candidate A) Brenden Koh**
